3 prehearing conference in Commission Case No. TE-2006-0415,  
4 in the matter of the application for waiver of MCC  
5 Telephony of Missouri, Inc. of compliance with the  
6 requirement of 4 CSR 240-32.

7 My name is Cherlyn Voss. I am the  
8 Regulatory Law Judge assigned to hear this case. We'll

13 everyone knows, for the prehearing conference is to get  
14 the parties together to address any discovery issues and  
15 to work towards establishing a procedural schedule with an  
16 evidentiary hearing. I've handed out copies of the very
