STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On February 15, 2011, the Commission received an Application to change the name of Ren-Tel Communications, Inc. d/b/a Dial Tone & More to Ren-Tel Communications, Inc. Tariffs reflecting the name change bearing an effective date of March 21, 2011, have been submitted as well.

2. Rule 4 CSR 240-2.060 establishes filing requirements for certificated company name changes; as noted in the attached Staff Memorandum, the Company has complied with the rule, including the customer notice provisions. No entities intervened to oppose the name change. The Company is not delinquent in any required filings with the Commission. The filed revised tariff sheets are compliant with Commission rules.

WHEREFORE, the Staff recommends that the Commission issue an Order Recognizing the Name Change, acknowledging the name under which the Company does business as Ren-Tel Communications, Inc. and allow revised tariff sheets under tracking numbers YC-2011-0411, YC-2011-0412, and YX-2011-0413 to go into effect by operation of law.
