ORDER RECOGNIZING NAME CHANGE

Effective Date: February 17, 2023

New Florence Telephone Company d/b/a Rally Networks filed a notice on January 4, 2023, indicating it has converted to an LLC and will be doing business as New Florence Telephone LLC d/b/a Rally Networks. The company also filed tariff changes to adopt the new name. On January 18, 2023, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name changes.

The Commission will recognize the name change. The tariff changes to adopt the name change took effect by operation of law on January 14, 2023.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of New Florence Telephone Company d/b/a Rally Networks to New Florence Telephone LLC d/b/a Rally Networks.
2. This order shall be effective on February 17, 2023.
3. This file shall be closed on February 18, 2023.
