MOTION FOR REINSTITUTION OF PROCEDURAL SCHEDULE

COMES NOW Alma Communications Company d/b/a Alma Telephone Company ("Alma"), by its counsel Andereck, Evans, Milne, Peace & Johnson, L.L.C., and submits this Motion to Reinstitute the Procedural Schedule previously Ordered in this docket. In support of this Motion, Alma and the undersigned counsel states:

1. On November 13, Mid-Missouri Cellular, Alma, and current counsel for Alma agreed to withdraw Alma's November 4 Motion to Suspend Procedural Schedule.
2. Alma was unable to present a motion to withdraw the Motion to Suspend prior to the Commission's November 13 vote on an Order Denying the Motion to Withdraw, and Suspending the Procedural Schedule.
3. The Commission's November 13 Order Denying Motion to Withdraw, and Suspending the Procedural Schedule is not yet effective, as its effective date is November 23, 2003.
4. No party or the Commission will be prejudiced by reinstituting the procedural schedule previously ordered. Counsel for Alma has communicated with all attorneys of record, and has obtained the consent of all parties to the reinstitution of the

procedural schedule in place prior to the November 13 Order suspending that procedural schedule.

WHEREFORE, Alma hereby requests that the Commission enter an Order reinstating the procedural schedule previously ordered in this case.
