4		December 2012 Company has paid invoices totaling \$228,401.17.

6	Q.	HAVE YOU REVIEWED COMPANY'S ESTIMATED COSTS TO DEVELOP AND
7		PROCESS THE INSTANT CASE?
8	А.	Yes. The Rate Case Expense workpaper provided by Company identified the estimated
9		cost of the instant case as \$500,000.
10		
11	Q.	PLEASE SUMMARIZE THE PUBLIC COUNSEL'S POSITION ON THIS ISSUE.
12	А.	Public Counsel believes that the amount of rate case expense included in the development
13		of the Company's rates should only include a normalized annual level of charges.
14		
15	Q.	WHAT IS THE ANNUALIZED AMOUNT OF RATE CASE EXPENSE YOU ARE
16		PROPOSING THAT THE COMPANY RECEIVE?
17	А.	As of the time this testimony is given, the Company has incurred rate case expense costs
18		of \$228,401.17 through December 2012. The amount of rate case expense Public
19		Counsel is proposing is \$114,200.59, based on a two-year normalization.
