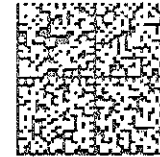

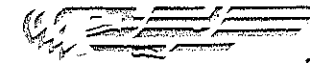

TIME TO RESPOND TO MOTION**

On June 3, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting Jefferson Plaza Investors, Inc., d/b/a Blue Springs Office Suites' ("Blue Springs") certificate of service authority to provide shared tenant telecommunications services in the State of Missouri be cancelled. The Commission granted Blue Springs a certificate of service authority to provide shared tenant telecommunication service in the State of Missouri in File Number TA-99-411.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.






