



On August 3, 2018, the Commission issued its Notice of Contested Case and Order Directing Filing (“Notice”), directing that Blue Jay be served by certified mail, postage prepaid, to Blue Jay Wireless, LLC, 5010 Addison Circle Addison TX 75001; and directing that Blue Jay file an answer no later than September 3, 2018. On August 24, 2018, the undelivered Notice was filed in EFIS. Blue Jay has not filed an answer.

The Commission will grant Staff’s motion.

**THE COMMISSION ORDERS THAT:**

1. Blue Jay Wireless, LLC’s designation as an Eligible Telecommunications carrier in order to qualify and receive federal universal service support for Lifeline and Disabled programs is cancelled.
2. This Order shall be effective on September 14, 2018.
