Dear Secretary/Chief RLJ Roberts:

On May 5, 2004, counsel for Adelpia Business Solutions, Inc. d/b/a TelCove ("TelCove"), the ultimate parent of Adelpia Business Solutions Operations, Inc. d/b/a TelCove, notified the Missouri Public Service Commission ("Commission") that TelCove had emerged from bankruptcy. The letter also notified the Commission that as a result of the emergence from bankruptcy the name of the Missouri operating entity, Adelpia Business Solutions Operations, Inc. d/b/a TelCove, was changed to TelCove Operations, Inc. The letter also indicated that TelCove would make an official name change filing with the Commission as soon as TelCove received final documentation from the Missouri Secretary of State.

Accordingly, enclosed for filing are an original and three (3) copies of this letter, proof of filing of the Amended Certificate of Authority of a Foreign Corporation with the Missouri Secretary of State, and adoption notices with revised title pages reflecting the name change on the tariffs.

In addition, kindly modify your records to list the following individual as the regulatory contact for TelCove:



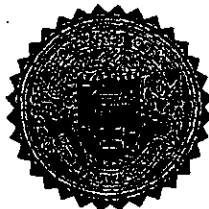
