Comes now Chariton Valley Telephone Corporation, and hereby requests that the Commission take notice of the attached Amendment to the May 22, 2002 Interconnection Agreement between Chariton Valley Telephone Corporation and Missouri RSA No. 5 Partnership, d/b/a Chariton Valley Wireless. In Support of this request Chariton Valley states as follows:

- On May 22, 2002, Chariton Valley Telephone and Chariton Valley
 Wireless executed an Interconnection and Reciprocal Compensation Agreement.
- 2. On June 10, 2002, Chariton Valley Telephone and Chariton Valley Wireless filed an Application with the Commission for Approval of this Agreement pursuant to Section 252 of the 1996 Telecommunications Act.
- 3. On July 8, 2002 the Commission entered an Order approving said Interconnection Agreement.
- 4. In the Order approving the Agreement, the Commission stated it did not intend to conduct a full approval proceeding each time the parties agreed to a modification. The Commission stated that when a modification was identical to that

contained in another approved agreement, the Commission will take notice thereof once Staff verifies the provision is an approved provision.

- 5. In other approved traffic termination agreements between Chariton Valley Telephone Corporation and other CMRS providers, in which the CMRS provider connects indirectly with Chariton Valley Telephone Corporation, the compensation rate for intraMTA wireless to landline traffic has been approved at 3.5 cents per minute. See the Traffic Termination Agreements approved between Chariton Valley Telephone and Sprint PCS (TK-2004-0543), Cingular (TK-2004-0518), and Alltel (TK-2005-0189).
- 6. Missouri RSA 5 d/b/a Chariton Valley Wireless interconnects directly with Chariton Valley Telephone, and the parties exchange traffic on a reciprocal basis. Chariton Valley Wireless has requested the same intraMTA rate as has been agreed to with the other CMRS providers. Chariton Valley Telephone has agreed. The Parties have entered into the attached Amendment to Section "3.3.1 Rates".

Relief Requested

7. Chariton Valley states, and hereby requests Staff to verify, that this 3.5 cent intraMTA rate provision is the same as is contained in other approved agreements. Chariton Valley also requests the Commission, based on this statement and Staff's verification, to take Notice of this Amendment to the Interconnection Agreement approved in TK-2002-1121.

AMENDMENT TO MAY 22, 2002 AGREEMENT FOR INTERCONNECTION AND RECIPROCAL COMPENSATION BETWEEN CHARITON VALLEY TELEPHONE CORPORATION AND MISSOURI RSA NO. 5 PARTNERSHIP D/B/A CHARITON VALLEY WIRELESS

Come now Chariton Valley Telephone Corporation and Missouri RSA No. 5 Partnership d/b/a Chariton Valley Wireless and enter into the following Amendment to Section 3.3.1 of the May 22, 2002 Agreement for Interconnection and Reciprocal Compensation, as approved by the July 8, 2002 Order of the Missouri Public Service Commission in Case No. TK-2002-1121, to be effective on the first monthly billing cycle following approval of this Amendment by the Missouri Public Service Commission:
