**MOTION TO RESCHEDULE HEARING**

COMES NOW Intervenor Spectra Communications Group, LLC, d/b/a CenturyTel ("Spectra"), pursuant to 4 CSR 240-2.080, and for its Motion To Reschedule Hearing respectfully states as follows:

1. On July 8, 2004 the Commission issued its *Order Granting Motion For A Hearing And Adopting Procedural Schedule*, wherein pursuant to the unanimous request of the parties, it set this case for evidentiary hearing on October 20-21, 2004.
2. Applicant filed its Direct Testimony on August 5, 2004. Based on that testimony, Spectra determined that it would need to retain an outside consultant to address certain issues raised by Applicant. Spectra's outside consultant, however, advised that he had an unavoidable scheduling conflict on October 20-21, 2004. This information was not available to Spectra at the time it agreed to the unanimous procedural schedule submitted by the parties on June 21, 2004.
3. Counsel for Spectra has contacted counsel for all parties in this case and they have indicated that none oppose moving by one week the evidentiary hearing to October 27-28, 2004 and keeping the remaining procedural schedule the same as previously ordered. Staff counsel has indicated that the Commission's calendar should allow for this rescheduling and moving the hearing ahead one week does not create a scheduling

conflict for any party with out-of-state witnesses. Moving the hearing date to any other dates in October, however, would create scheduling problems for the out-of-state witnesses.

WHEREFORE, Spectra respectfully requests that the Commission modify the procedural schedule in this case by rescheduling the evidentiary hearing currently set in this case for October 20-21, 2004 to October 27-28, 2004.
