**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE**  
**WITH COMMISSION ORDER**

Issue Date: January 22, 2007

Effective Date: March 1, 2007

On May 18, 2006, the Commission issued an order approving a Stipulation and Agreement filed by the Staff of the Commission, the Office of the Public Counsel, and CenturyTel of Missouri, LLC, in which the parties agreed, among other things, that the CenturyTel exchanges of Foley, Holstein, Marthasville, Warrenton, and Wright City would be added to the St. Louis Metropolitan Calling Area (MCA) as a new Tier 6. The order directed CenturyTel to file tariff sheets with an effective date that is the earliest possible date the provisions of the Stipulation can be implemented. CenturyTel submitted tariff sheets (Tariff File No. YI-2006-0946) on June 19, 2006, with an effective date of March 1, 2007.

Staff filed its recommendation and memorandum on January 17, 2007. Staff states that CenturyTel's proposed tariff outlines the terms, conditions, and rates as contained in the Stipulation. Accordingly, Staff has no objection to CenturyTel's proposed tariff filing and recommends that the Commission approve the tariff sheets to become effective on March 1, 2007.

The Commission has reviewed the record in this matter, including Tariff No. YI-2006-0946, and the Staff's recommendation and memorandum, which are hereby admitted into evidence. The Commission finds that CenturyTel's tariff complies with the Commission's previous order and will approve the tariff to become effective on or after March 1, 2007.

The Commission notes that this case was bifurcated for the Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, exchanges involved (Washington, Union, St. Clair, and Beaufort). AT&T's compliance tariff was approved by the Commission by order issued October 4, 2006, to become effective on and after October 30, 2006. Since all pending matters have now been addressed and no further Commission action is required, the Commission will close this case.

**IT IS ORDERED THAT:**

1. Tariff No. YI-2006-0946, filed by CenturyTel of Missouri, LLC, on June 19, 2006, is approved for service rendered on or after March 1, 2007. The tariff sheets approved are:
