ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: June 7, 2006

Effective Date: June 29, 2006

On January 10, 2006, the Commission issued an order approving a Stipulation and Agreement filed by the Staff of the Commission, the Office of the Public Counsel, and Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, in which the parties agreed, among other things, that the Greenwood exchange will become a mandatory Metropolitan Calling Area (MCA) Plan exchange in the Kansas City MCA. The order directed AT&T Missouri to file tariff sheets with an effective date that is the earliest possible date the provisions of the Stipulation can be implemented. After submitting and withdrawing two tariff filings, AT&T Missouri submitted tariff sheets (Tariff File No. YI-2006-0828) on April 28, 2006, with an effective date of June 29, 2006.

Staff filed its recommendation and memorandum on June 5, 2006. Staff states that AT&T Missouri's proposed tariff outlines the terms, conditions, and rates as contained in the Stipulation, with the exception of an increase in the rates for business customers. Staff explained that since the Stipulation was entered into, rate revisions have occurred. Effective March 3, 2006, the basic local charge for single-line business customers

increased from \$22.30 to \$23.30, and the basic local charge for multi-line business customers increased from \$37.80 to \$38.80. Staff goes on to state that AT&T Missouri has voluntarily reduced the \$11.00 extended area service (EAS) charge for business customers from \$11.00 to \$10.00 to offset this \$1.00 increase. Staff states that despite the overall \$1.00 increase to the business customer base rates, Staff believes the tariff sheets still conform to the Stipulation and the Commission's order.

Staff notes further that as part of Tariff No. YI-2006-0828, AT&T Missouri filed tariff sheets that reference the addition of the Washington, Union, St. Clair and Beaufort exchanges in the St. Louis MCA to prevent a tariff "pancaking" issue with the tariff filed in Case No. TO-2005-0141.

Accordingly, Staff has no objection to AT&T Missouri's proposed tariff filing and recommends that the Commission approve the tariff sheets to become effective June 29, 2006.

The Commission has reviewed the record in this matter, including Tariff No. YI-2006-0828 and the Staff's recommendation and memorandum. The Commission finds that the tariff substantially conforms to the agreements in the Stipulation. The Commission finds, further, that the reference in the tariff to the St. Louis MCA exchanges of Washington, Union, St. Clair and Beaufort is acceptable in order to avoid a tariff "pancaking" issue with the tariff filed in Case No. TO-2005-0141.

The Commission will therefore approve AT&T Missouri's tariff.
