**STIPULATION OF FACT RELATED TO TRUE-UP
AND MOTION TO SUSPEND TRUE-UP PROCEDURAL SCHEDULE**

COME NOW Missouri-American Water Company (“MAWC” or the “Company”), and the Staff of the Missouri Public Service Commission (“Staff”), (collectively, the “Signatories”), by and through their respective counsel, and, for their Stipulation of Fact Related to True-Up (this “Stipulation of Fact”), respectfully state as follows to the Missouri Public Service Commission (“Commission”):

1. This Stipulation of Fact is being entered into solely for the purpose of addressing the single fact remaining at issue in the True-Up process in this case given the stipulations that have been previously presented to the Commission. This Stipulation of Fact does not address any other factual determinations or contested issues remaining at issue in this case. Although some negotiation was involved in the drafting of the language of this Stipulation of Fact, the subject matter that is being stipulated to is not the result of negotiation. Each of the parties independently reviewed and verified actual costs and each of the parties agree that each others’ tabulation of the actual costs is the same.

2. **Lead Service Line Deferral:** The Signatories agree that as of December 31, 2017, the value of the regulatory asset authorized by the Commission in Case No. WU-2017-0296 was \$1,757,869. These costs are the result of the replacement of 240 residential customer-owned lead service lines.

3. In light of this Stipulation of Fact, the Signatories move the Commission to suspend

the true-up procedural schedule in this case (True-Up Direct – March 14, 2018; True-Up Rebuttal – March 23, 2018; True-Up Hearing – April 2, 2018; and True-Up Brief – April 9, 2018).

WHEREFORE, the Signatories respectfully request the Commission consider the fact stipulated to herein and move the Commission to suspend the true-up procedural schedule in this case as described above.
