

Dear Nathan:

This letter responds to your voicemail of April 19, 2005 when you agreed to LEC's proposed resolution of the dispute over Subpoena Two, item 3(b) and 3(b)(i) by expanding the list of affected individuals to include those who have signature authority on LEC checking accounts. You identified Dee Coburn, Debi Long and Jeannie Livingston as having this authority. In fact, of the individuals you identified, only Ms. Long has signature authority. LEC agrees to expand the listing of affected individuals to include Ms. Long. Accordingly, compliance with Subpoena Two, item 3(b) and 3(b)(i) requires the production of responsive documents, found after a reasonable search, that identify Mr. Matzdorff, Mr. Williams, Ms. Matzdorff or Ms. Long as holding an ownership or salary interest in a business that did business with LEC, within the time period January 1, 1996 – present. With this modification, all disputes between staff and LEC related to the subpoenas have been resolved.
