On August 30, 2005, Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, filed its Petition for Competitive Classification pursuant to Section 392.245.5, RSMo (Supp. 2005). The Commission conducted an evidentiary hearing in this matter on September 16, 2005. The Commission finds that it would be aided in its review if certain non-parties, Big River Telephone Company, Sprint Communications Company, L.P., and NuVox Communications of Missouri, Inc., would expeditiously file pleadings addressing the following questions:

- 1. Big River: Is Big River providing basic local telecommunications services in the following exchanges: Farmington, Sikeston, Bonne Terre, and Marble Hill?
- 2. NuVox: Is NuVox providing basic local telecommunications services in the Excelsior Springs exchange?
- 3. Sprint: Is Sprint providing basic local telecommunications services in the following exchanges: San Antonio and St. Joseph?

The Commission will also direct its Staff to expeditiously file a supplemental pleading clarifying, for each wireless or commercial mobile radio service company that SBC Missouri lists in its application or testimony as a competitor, whether that wireless company offers its customers a local phone number.

The Commission will also direct that all pleadings filed in response to this order shall be accompanied by verified affidavits.

IT IS THEREFORE ORDERED:

- That no later than 3:00 p.m. on September 20, 2005, Big River Telephone
 Company, NuVox Communications of Missouri, Inc., and Sprint Communications Company,
 L.P., shall expeditiously file pleadings as directed above.
- 2. That no later than 12:00 p.m. on September 21, 2005, any party may file a response to these pleadings of Big River Telephone Company, NuVox Communications of Missouri, Inc., and Sprint Communications Company, L.P., as directed above.
- 3. That no later than 3:00 p.m. on September 20, 2005, the Commission's Staff shall file a supplemental pleading as directed above.
- 4. That no later than 12:00 p.m. on September 21, 2005, any party may file a response to Staff's supplemental pleading, as directed above.
- 5. That all pleadings filed in response to this order shall be accompanied by verified affidavits.
- 6. That the Commission's Data Center shall send a copy of this order to the following non-parties: Big River Telephone Company; NuVox Communications of Missouri, Inc.; and Sprint Communications Company, L.P.

7. That this order shall become effective on September 19, 2005.
