## ORDER DIRECTING NOTICE OF PETITION FOR ARBITRATION

On October 4, 2005, a number of small rural carriers<sup>1</sup> filed a petition for arbitration with the Missouri Public Service Commission pursuant to the Telecommunications Act of 1996, requesting that the Commission arbitrate unresolved issues with Sprint PCS.

As Sprint PCS is a party to the agreement, the Commission finds that Sprint PCS is necessary and indispensable to a resolution of this matter and shall be made a party. The Commission will direct the Data Center to provide notice of this petition to Sprint PCS, and Sprint PCS shall be permitted to file a response to the petition with any additional information it chooses to provide.

Furthermore, finding that there is a need to protect confidential information, the Commission will issue its standard protect order. The Commission has previously recognized the need to protect confidential information, and protective orders have helped minimize disputes in past cases.
