

**SECOND QUARTERLY STATUS REPORT  
OF WORLDCOM, INC., AND ITS U.S. SUBSIDIARIES**

WorldCom, Inc., and its United States subsidiaries<sup>1</sup> that are authorized to provide telecommunications service in the state of Missouri (collectively WCom) file their second joint quarterly status report as required by the Order Establishing Case of the Missouri Public Service Commission (Commission) in the above styled and numbered docket.

**I. Current Status of Bankruptcy Case**

WCom has had a highly eventful November as its 63,000 employees work their way through the Chapter 11 bankruptcy.

On November 15, 2002, WCom announced that it had named Michael D. Capellas as Chairman and CEO. Mr. Capellas is the former president of Hewlett-Packard Company. Prior to HP, he was Chairman and CEO of Compaq Computer Corporation. "I took this job because I am convinced that WorldCom has the assets, the customers and the people to regain a leadership role in this industry," he said. "In order to do this, we must first regain trust and win respect.

Accordingly, together we will rebuild WorldCom into a model of good corporate governance and management integrity.” Mr. Capellas said he also was encouraged by the company’s stabilized financial position, including more than \$1.4 billion in cash, as well as the steps that current management has taken to ensure the improper conduct that occurred in the past cannot happen at the company in the future.

On November 11, 2002, WCom filed its September 2002 Monthly Operating Report with the U.S. Bankruptcy Court. During the month of September 2002, WorldCom recorded \$2.3 billion in revenue, \$416 million in earnings before interest, taxes, depreciation and amortization (EBITDA) and a net loss from continuing operations of \$108 million. During September, WorldCom’s capital expenditure of approximately \$98 million was focused on line cost reductions and new products – such as The WorldCom Connection, The Neighborhood and IP-based virtual private networks. WCom ended September with approximately \$1.4 billion in cash on hand, an increase of \$200 million from the beginning of the period.

On November 4, 2002, following the filing with the Bankruptcy Court of the preliminary report from Richard Thornburgh, WCom’s court-appointed examiner, WCom announced that it had taken a series of actions designed to restore confidence in the company and rebuild its integrity and business practices. WCom has developed and implemented new systems, policies and procedures; reorganized its finance and accounting functions; and implemented organizational changes intended to help correct the company’s past problems, pre-empt their reoccurrence and create a system that will permit its newly-appointed independent auditors to complete their review of the financial statements for the years 2000, 2001 and

2002. In addition to a new chairman and CEO, WCom has a new CFO, Chief Restructuring Officer, legal and financial advisors, and members of the Board of Directors:

- Nicholas deB Katzenbach, former US Attorney General, Under Secretary of State and Senior VP and General Counsel of IBM,
- Dennis Beresford, Professor of Accounting at the Terry College of Business at the University of Georgia and former Chairman of the Financial Accounting Standards Board; and
- C.B. Rogers, Jr., Chairman and CEO of Equifax, Inc. and who has served on the Board of such companies as Sears, Roebuck & Co., Dean Witter and Briggs & Stratton Corp.

## **II. Impact on Customers**

WorldCom's bankruptcy filing has not disrupted service to its customers in Missouri. MCI continues to promote The Neighborhood local and long distance product, launched during mid-April in Missouri to residential and small business customers in Southwestern Bell exchanges.

## **III. Conclusion**

WCom appreciates to opportunity to continue serving Missouri consumers with quality and competitive telecommunications service. 
