# REPORT OF SPECTRA COMMUNICATIONS GROUP, LLC d/b/a CENTURYTEL TO MISSOURI PUBLIC SERVICE COMMISSION

Comes now Spectra Communications Group, LLC d/b/a CenturyTel ("Spectra") and for its Report to the Missouri Public Service Commission ("Commission") states as follows:

- 1. On October 24, 2002, the Commission issued its Order Dismissing Complainant and Directing Filing in this case in which it directed Spectra to file a report no later than November 27, 2002, regarding the refund of incorrectly charged late fees. This report was to state the number of customers affected and the total amount of the credits issued.
- 2. Spectra has now completed its refunds of the late fees that were charged in error.

  During the month of October, Spectra made refunds totaling \$322,042 to 68,937 customers. The number of customers refunded is less than the number previously reported to the Commission, because some customers included in the first number are no longer receiving service from Spectra and are no longer active in the billing system. Federal tax in the amount of \$10,734 was also refunded.

Wherefore, Spectra respectfully requests that the Commission accept its Report to the Commission.
