#### STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Commission), by and through counsel, and submits its *Staff Recommendation* as follows:

- 1. On August 26, 2009, Embarq Missouri, Inc., d/b/a Embarq (Embarq or Applicant) submitted to the Commission its Applicant of Embarq Missouri, Inc., d/b/a Embarq for approval of an interconnection, collection, and resale agreement (Agreement) between Charter Fiberlink Missouri, LLC (Charter) and Embarq pursuant to the Telecommunications Act of 1996.
- 2. On September 1, 2009, the Commission issued its *Order Directing Notice and Making Charter Fiberlink Missouri, LLC a Party*, making Charter a party to this case, requesting any party wishing a hearing to file a pleading no later than September 21, 2009, and Staff to file a memorandum no later than October 1, 2009.
  - 3. No party filed a request for a hearing by September 21, 2009.
- 4. The statutory standard for review of an interconnection and resale agreement can be found in Section 252(e) of the Telecommunications Act of 1996, states that an interconnection agreement adopted by negotiation shall be submitted for approval to the state commission, but that the state commission may only reject such agreement if it discriminates against a telecommunications carrier not a party to the agreement or if its implementation is not consistent with the public interest, convenience, and necessity. 42 U.S.C. § 252(e)(2).

- 4. In the attached Memorandum, labeled Appendix A, Staff states that the Interconnection Agreement does not discriminate against telecommunications carriers not parties to the Interconnection Agreement and that the Interconnection Agreement is not against the public interest, convenience or necessity.
- 5. Embarq is not delinquent in filing its annual report, or in paying its PSC assessment, or MoUSF and Relay Missouri surcharges.

WHEREFORE, Staff recommends the Commission approve Embarq's Application and direct the parties to submit to the Commission any subsequent modifications or amendments to the Interconnection Agreement.
