## STAFF'S RECOMMENDATION TO ACCEPT FILED AMENDMENT AND APPROVE PREVIOUS APPLICATION

**COMES NOW** the Staff of the Missouri Public Service Commission and submits its Recommendation as follows:

- 1. On January 3, 2020, Embarq Missouri, Inc. d/b/a CenturyLink ("CenturyLink") filed with the Missouri Public Service Commission its *Application for Approval of the Transport Rate Amendment to the Interconnection Agreement* ("Application") between itself and CSC Wireless, LLC d/b/a Altice Mobile ("Altice Mobile").
- 2. On January 6, 2020, the Commission issued its *Order Directing Notice*, Setting Intervention Deadline, and Making CSC Wireless, LLC d/b/a Altice Mobile a Party ("Order").
- 3. On January 30, 2020, Staff filed its *Recommendation* with the Commission recommending the Commission approve the *Application*.
- 4. It has come to Staff's attention that the Application lacked a copy of the amendment to the interconnection agreement ("Amendment").
- 5. On February 7, 2020, CenturyLink filed a copy of the *Amendment* with the Commission. Staff examined the *Amendment* and states that the *Amendment* does not discriminate against telecommunications carriers not parties to it, nor is its implementation inconsistent with the public interest, convenience or necessity.

**WHEREFORE,** Staff recommends the Commission accept the filed *Amendment* and approve the *Application* and grant such other and further relief as the Commission finds appropriate in the circumstances.
