(hereinafter referred to as "GC" or "Seller") (together the "Applicants"), by their undersigned counsel, and for their response to the Commission's June 2, 2005 Order state the following:

1. Applicants state that the transaction described in its application is not complete.
2. Applicants concur with the Staff status reports filed on April 1, 2005 and May 27, 2005 in this matter.
3. On April 29, 2005, Matrix filed its application for a certificate of service authority to provide basic local telecommunications service along with a proposed basic local tariff. Staff has discussed with the undersigned counsel certain changes to the basic local tariff and the finalization of those revisions is not yet complete.
4. Matrix has not yet filed an application for approval of an interconnection

agreement and intends to prepare and file such an application in the near future.
