<u>PETITION FOR WRIT OF REVIEW</u> OF PUBLIC SERVICE COMMISSION DECISION

COME NOW Relators NuVox Communications of Missouri, Inc. (NuVox), MCI WorldCom Communications, Inc. (MCIWC), Brooks Fiber Communications of Missouri, Inc. (Brooks), MCImetro Access Transmission Services, LLC (MCImetro), TCG St. Louis (TCG St. Louis) and TCG Kansas City (TCG Kansas City) (hereinafter collectively referred to as "Relators"), pursuant to Section 386.510 R.S.Mo. and Section 536.100 et seq. R.S.Mo. and for their Petition for Writ of Review state to the Court:

1. NuVox is a Delaware corporation in good standing duly authorized to conduct business in Missouri. NuVox is authorized as a competitive local exchange carrier under certificates granted and tariffs approved by the Missouri Public Service Commission (Commission).
