ORDER RECOGNIZING NAME CHANGE

On June 13, 2022, pursuant to 20 CSR 4240-28.011(2), Northeast Missouri Rural Telephone Company submitted a letter advising that it had adopted “NEMR” as a fictitious name. Tariffs were submitted with the application, effective June 23, 2022. On June 16, 2022, the company supplemented its notice. On July 8, 2022, the Commission’s Staff filed a recommendation indicating that the company has complied with all regulatory requirements for the name change. Staff recommends the Commission recognize the name change. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Northeast Missouri Rural Telephone Company d/b/a NEMR Telecom to Northeast Missouri Rural Telephone Company d/b/a NEMR.
2. This order shall be effective on August 10, 2022.
3. This file shall be closed on August 11, 2022.
