## ORDER RECOGNIZING NAME CHANGE

New Florence Telephone Company d/b/a Missouricom, New London Telephone Company d/b/a Missouricom, Stoutland Telephone Company d/b/a Missouricom, Orchard Telephone Company d/b/a Missouricom, Farber Telephone Company d/b/a Missouricom, Seneca Telephone Company, Goodman Telephone Company, Ozark Telephone Company, S-Go Leasing Company d/b/a S-Go Local, and S-Go Leasing Company d/b/a S-Go Long Distance, submitted a letter on October 21, 2022, advising that they have adopted the fictitious name of Rally Networks. The various companies also filed tariff changes to adopt the new names. On November 7, 2022, the Commission's Staff filed a recommendation indicating the companies have complied with all statutory and regulatory requirements for changing their name. Staff recommends the Commission recognize the name changes. Staff also recommends that the tariff changes to adopt the new name be approved, or allowed to take effect by operation of law. The Commission will recognize the name changes and will allow the submitted tariffs to take effect by

operation of law. In addition, the Commission acknowledges the withdrawal of the following wireless termination tariffs: New Florence Telephone Company, PSC Mo. No. 2; Seneca Telephone Company, PSC Mo. No. 6; Goodman Telephone Company, PSC Mo. No. 5; and Ozark Telephone Company, PSC Mo. No. 6.

**THE COMMISSION ORDERS THAT:**

1. The Commission recognizes New Florence Telephone Company d/b/a Missouriicom's name change to New Florence Telephone Company d/b/a Rally Networks.

2. The Commission recognizes New London Telephone Company d/b/a Missouriicom's name change to New London Telephone Company d/b/a Rally Networks.

3. The Commission recognizes Stoutland Telephone Company d/b/a Missouriicom's name change to Stoutland Telephone Company d/b/a Rally Networks.

4. The Commission recognizes Orchard Telephone Company d/b/a Missouriicom's name change to Orchard Telephone Company d/b/a Rally Networks.

5. The Commission recognizes Farber Telephone Company d/b/a Missouriicom's name change to Farber Telephone Company d/b/a Rally Networks.

6. The Commission recognizes Seneca Telephone Company's name change to Seneca Telephone Company d/b/a Rally Networks.

7. The Commission recognizes Goodman Telephone Company's name change to Goodman Telephone Company d/b/a Rally Networks.

8. The Commission recognizes Ozark Telephone Company's name change to Ozark Telephone Company d/b/a Rally Networks.

9. The Commission recognizes S-Go Leasing Company d/b/a S-Go Local's name change to S-Go Leasing Company d/b/a Rally Networks.
