MOTION FOR EXPEDITED TREATMENT

COMES NOW Aquila, Inc. (Aquila), and, in accordance with Missouri Public Service Commission (Commission) Rule 4 CSR 240-2.080(16), moves the Commission for expedited treatment of Aquila's proposed tariff sheet, filed on August 8, 2007 (Tracking No. YH-2008-0100):

1. In Case No. HR-2005-0450, the Commission approved a Quarterly Cost Adjustment Rider for Aquila's steam service. This case concerns the 2007 quarterly filings.

2. On July 13, 2007, Aquila filed a steam service tariff sheet (and supporting calculations) providing for the Quarterly Cost Adjustment for service rendered on and after September 1, 2007 (YH-2008-0039). The Commission issued its Order Directing Filing on July 18, 2007, directing that the Staff file its recommendation concerning this tariff sheet no later than August 20, 2007.

 Since that time, Aquila has become aware of changes that must be made to both the tariff sheet filed on July 13, 2007, and the supporting calculations.
Accordingly, on August 8, 2007, Aquila withdrew the tariff sheet identified by Tracking No. YH-2008-0039.

4. Also, on August 8, 2007, Aquila filed a new tariff sheet providing for the Quarterly Cost Adjustment, along with supporting calculations (Tracking No. YH-2008-0100). A copy of that filing is provided with this Motion. The new tariff sheet bears an issue date of August 8, 2007, and a proposed effective date of September 7, 2007 (30 days).

5. The Stipulation and Agreement in Case No. HR-2005-0450 indicates that "Aquila will make quarterly filings to adjust the fuel rider." As the next quarter will begin on September 1, 2007, Aquila seeks expedited treatment of the proposed tariff sheet so that it may become effective on September 1, 2007.

6. The Commission has authorized the adjustment process reflected in the Case No. HR-2005-0450 Stipulation and Agreement. Granting this Motion will provide a rate adjustment consistent with that process. As such, the Commission action requested herein will cause no negative effect on Aquila's customers or the public generally.

7. The subject tariff sheets and this Motion have been filed as soon as possible after it became apparent to Aquila that it had a need to modify the previously filed tariff and supporting calculations.

WHEREFORE, for the foregoing reasons, Aquila respectfully requests the Commission to grant Aquila's Motion for Expedited Treatment and approve Aquila's proposed tariff sheet (Tracking No. YH-2008-0100) effective September 1, 2007.
