COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On June 14, 2006, Embarq Missouri, Inc., (formerly known as Sprint Missouri, Inc.) filed a motion to cancel the company's Wireless Termination Service Tariff No. 11 in its entirety.

2. The company had previously deleted all textual content of Tariff No. 11, effective July 5, 2005, through a tariff revision submitted in Tariff File No. JI-2005-1081.

3. In the attached Memorandum, which is labeled Appendix A, the Staff recommends the cancellation of Tariff No. 11.

WHEREFORE, the Staff recommends cancellation of the Sprint Missouri, Inc. d/b/a Sprint P.S.C. Mo. – No. 11 Wireless Termination Service Tariff.

Additional Comments:

1. Wireless Termination Service Tariff P.S.C. MO.-No. 11 (Tariff 11) offered termination to end users for traffic originated from Commercial Mobile Radio Service (CMRS ["Wireless" or "Cellular"]) providers that were not directly connected with Sprint Missouri, Inc. d/b/a Sprint (Sprint), now Embarq, and was transited through the network of a third-party carrier.
2. Tariff 11 was restricted only to CMRS wireless-to-wireline traffic that originated and terminated within the same Major Trading Area (MTA), termed intraMTA traffic. Such traffic is subject to per-minute rates, which does not apply to traffic subject to Interconnection or other Agreements between Sprint and CMRS providers.
3. Effective July 05, 2005, all textual content of Wireless Termination Service Tariff P.S.C. MO.-No. 11 was deleted under File No. JI-2005-1081.
4. Effective June 04, 2006, the name of Sprint was approved as changed to Embarq Missouri, Inc., d/b/a Embarq under Case No. TN-2006-0416 *et al.*
5. Embarq adopted Sprint's tariffs P.S.C. MO.-Nos. 10, 22, 23, 24, 25 and 26 under File Nos. YI-2006-0837 *et al* along with the name change. Tariff 11 was not included in that proceeding.


