MOTION FOR ADDITIONAL TIME TO FILE PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission, on behalf of itself and the other parties to this case, and states:

- 1. On August 28, 2007, Level 3 Communications, L.L.C., issued tariff sheets to add Toll Free Data Base Access service, Toll Free Transit Traffic service, and rates for Originating Access and Pay Telephone compensation. The Tariff sheets bore a proposed effective date of September 27, 2007.
- 2. On September 19, 2007, AT&T Communications of the Southwest, Inc., Southwestern Bell Telephone Company, d/b/a AT&T Missouri, and SBC Long Distance, LLC, d/b/a AT&T Long Distance (collectively referred to as AT&T) filed a motion asking the Commission to suspend and investigate Level 3's proposed tariff sheets.
- 3. In the Order issued on September 25, the Commission suspended the tariff sheets to October 27. In an Order issued October 22, the Commission further suspended the tariff sheets to November 27, 2007.
- 4. In the October 22 Order, the Commission also directed that no later than November 5, the parties shall jointly or separately file a proposed procedural schedule or a request for additional time to do so. The Commission has granted motions to extend that filing date to November 9 and then to November 16, 2007.
- 5. The Staff, on behalf of itself, Level 3, AT&T and the Office of Public Counsel, requests the Commission to further extend the that filing date to November 28, 2007.

6. The parties also propose that the tariff sheets should be further suspended to December 7, 2008.
