
On April 12, 2006, the Commission's Staff filed a motion asking the Commission to cancel the certificate of service authority to provide water and sewer service, as well as the tariffs, of Woodland Heights Utilities, Inc. Staff's motion indicates that Woodland Heights ceased operations around 1997 and that it transferred its assets to another entity. Staff also reports that Woodland Heights has been administratively dissolved and is no longer in business.

The Commission will order Woodland Heights to respond to Staff's motion. If Woodland Heights fails to respond, Staff's motion may be granted without further notice.

IT IS ORDERED THAT:

1. Woodland Heights Utilities, Inc., shall file a response to Staff's Motion to Cancel Certificate of Service Authority and Tariff no later than May 16, 2006.
2. This order shall become effective on April 17, 2006.
