





On February 7, 2007, the Commission's Staff filed a motion asking the Commission to cancel the certificate of service authority to provide water service to the Southwest Village Subdivision in Greene County, Missouri, as well as the tariff of Southwest Village Water Company. Staff's motion indicates that Southwest Village has ceased operations, the customers formerly served by Southwest Village are now served by another entity and the company has no objection to its certificate cancellation.

The Staff's motion notes that the former customers of Southwest Village have been receiving safe and adequate service from City Utilities of Springfield since 1997. The Staff further notes that the property of Southwest Village was not transferred, but has simply been abandoned. Finally, the Staff opines that the Commission has the authority and cause to cancel this certificate.

The Commission will order Southwest Village to respond to Staff's motion. If Southwest Village fails to respond, Staff's motion may be granted without further notice.

IT IS ORDERED THAT:

1. Southwest Village Water Company shall file a response to Staff's Motion to Open Case and Cancel Certificate of Convenience and Necessity and Tariff no later than March 16, 2007.
2. This order shall become effective on February 16, 2007.


