Tariffs Governing Rendering of Sewer Service

Dear Mr. Reed:

In the Order Dismissing Contested Case and Granting Certificate of Convenience and Necessity (CCN) in Case No. SA-2010-0063 dated April 21, 2010 with an effective date of May 3, 2010, as a condition of its grant of the CCN, the Commission in Ordered: 2.c. ordered that "No later than June 18, 2010, the company shall file new and revised tariff sheets, for its existing tariff, bearing an effective date not less than 30 days after filing." The only two sheets that need to be revised at this time are the tariffs pertaining to its map and area legal description.

Enclosed for filing find the following tariff sheets: P.S.C. MO No. 2, 1st Revised Sheet No.2 (the map) and 1st Revised Sheet No. 3 (the legal description) of Timber Creek Sewer Company's Rules Governing Rendering of Sewer Service.

For your information, the change to Sheet No. 3, the legal description, only involved Area 1, while Area 2 remained unchanged. The new description for Area 1 deletes the existing Area 1 description: "All of the Southeast 1/4 of the Southeast 1/4 of Section 32, and all of the Southwest 1/4 of Section 33, Township 53N, Range 34W, in Platte County, East of Platte City." The reason for the deletion is because all of Sections 32 and 33 are included in the new legal description, thus, the continuation of the old language pertaining to only a portion of such sections would be superfluous.

The new legal description for Area 1 is virtually the same as the Legal Description attached as Appendix 2 to the Application with the exception that all language referring to


"adjoining Timber Creek Sewer Company's existing Timber Creek Service Area" has been deleted. This is because Timber Creek's existing Timber Creek Service Area in Sections 32 and 33 is now included within the new legal description for Area 1. Thus, such deleted language is no longer necessary and in fact could be confusing were it kept in.
