1. On September 19, 2005, the Commission issued its Order Directing Filing requesting Sprint to expeditiously address the following question: Is Sprint providing basic local telecommunications services in the following exchanges: San Antonio and St. Joseph?


2. Sprint is providing basic local telecommunications services via UNE-P in the San Antonio and St. Joseph exchanges.


