- JUDGE DIPPELL: This is Case No.
- 3 TO-2007-0053, in the matter of the review of competitive
- 4 classification of the exchanges of Southwestern Bell
- 5 Telephone, L.P., d/b/a AT&T Missouri.
- 6 My name is Nancy Dippell. I'm the
- 7 Regulatory Law Judge assigned to this matter. And we came
- 8 here today for a procedural conference. I'll let the
- 9 attorneys make their entries of appearance. Mr. Lane,
- 10 would you like to begin?
- 11 MR. LANE: Sure. Paul Lane on behalf of
- 12 Southwestern Bell Telephone, L.P., doing business as AT&T
- 13 Missouri. My address is One AT&T Center, Room 3520,
- 14 St. Louis, Missouri 63101.
- JUDGE DIPPELL: Mr. Haas?
- MR. HAAS: Good morning. William K. Haas
- 17 appearing on behalf of the Staff of the Public Service
- 18 Commission. My address is Post Office Box 360,
- 19 Jefferson City, Missouri 65102.
- MR. DANDINO: Good morning, your Honor.
- 21 Michael Dandino, Office of the Public Counsel, Post Office
- 22 Box 2230, Jefferson City, Missouri 65102, representing the
- 23 Office of the Public Counsel and the public.
- JUDGE DIPPELL: Okay. Basically, like I
- 25 say, I just wanted you guys to talk about procedure. And

1 I should just state for future things, even if I don't put

- 2 telephone conference in a notice, you're always welcome to
- 3 call and ask me if you can appear by phone. And if
- 4 there's some reason I want you here in person, I'll let
- 5 you know. But I just don't always set that up or say
- 6 anything about it.
- 7 Anyway, it looks like we need to schedule
- 8 an evidentiary hearing, and so I brought the Commission's
- 9 calendar and I kind of updated it for my bad days and
- 10 things that were on the calendar already. I just printed
- 11 it out through December, figuring we wanted to do this
- 12 sooner rather than later.
- 13 MR. DANDINO: Not really. I don't have a
- 14 witness that's available 'til into the new year.
- JUDGE DIPPELL: Well, I'll let you guys
- 16 figure that out. If you need more days --
- MR. DANDINO: Do they have hearing dates?
- 18 JUDGE DIPPELL: There are some hearing
- 19 dates scattered in among there between now and the end of
- 20 the year. I think Christmas Eve is a holiday, so I don't
- 21 think that's a good one. Maybe it's Christmas Day this
- 22 year. Anyway, there are a few days in there which I
- 23 actually highlighted in yellow.
- 24 MR. LANE: Do you have a calendar for next
- 25 year?

1 JUDGE DIPPELL: I didn't bring it down, but
```

- 2 I can certainly get you guys one, or Mr. Haas can find it
- 3 for you hopefully. You can look at the calendar on our
- 4 Internet site. I don't know if --
- 5 MR. DANDINO: That, I think, only goes up
- 6 to February.
- 7 JUDGE DIPPELL: Well, it should now go for
- 8 at least 12 months. If you find when you're looking at it
- 9 that it doesn't go beyond 12 months, give Lonnell or
- 10 someone a call, because it just means that it accidentally
- 11 got changed. There's a little button they have to click.
- 12 MR. DANDINO: I think there was a -- when
- 13 we were trying to figure out for another hearing, like
- 14 April 18th was about the earliest we could get.
- JUDGE DIPPELL: A few things have changed
- 16 since then.
- 17 MR. DANDINO: That's fine.
- 18 JUDGE DIPPELL: And I wanted to ask Staff
- 19 if there was a particular time of year for -- they had
- 20 asked to do a yearly review, and if that gets ordered, I
- 21 just wanted to know if there was a particular time of year
- 22 that Staff would like that to fall. And you don't
- 23 necessarily have to answer today.
- MR. HAAS: I don't have an exact date, but
- 25 that time of year would need to be after the annual

- 1 reports are filed, and they come in on, I believe it's
- 2 April 15th.
- JUDGE DIPPELL: And I didn't know when the
- 4 CPI usually came out either.
- 5 MR. HAAS: I don't know.
- JUDGE DIPPELL: That would affect whether
- 7 or not companies were going to raise rates or lower rates
- 8 or --
- 9 MR. LANE: Not under competitive
- 10 classification.
- JUDGE DIPPELL: Oh, not under competitive.
- 12 Okay. See, this is why I came to ask you.
- MR. DANDINO: I think they come around
- 14 September, October.
- 15 JUDGE DIPPELL: Okay. Well, just something
- 16 to think about for Staff. And if you guys could file a
- 17 proposed procedural schedule this time next week, that
- 18 would be good, with a hearing date and any other, you
- 19 know, if you're planning on doing prefiled testimony or
- 20 whatever.
- 21 And the other thing I wanted to ask was,
- 22 Mr. Haas, are all of the exchanges in this review, does
- 23 this include all of the competitive exchanges or only the
- ones granted competitive status under the new statute?
- 25 There's some exchanges that are part of another pending

- 1 case that I'm the judge on that were competitive services.
- 2 MR. LANE: If I may, I think in terms of
- 3 competitive exchanges, the only ones that have been
- 4 declared were the ones that we're reviewing here. I think
- 5 we're reviewing all of them. The rest of those are
- 6 competitive services that were classified under a
- 7 different standard.
- JUDGE DIPPELL: So this case doesn't
- 9 necessarily include a review of those?
- MR. LANE: It does not.
- 11 JUDGE DIPPELL: But isn't there also review
- 12 of those things built into the statute?
- MR. LANE: No.
- 14 JUDGE DIPPELL: Okay. It's been a while
- 15 since I've read the statute in its entirety.
- Okay. Well, that's all the questions I
- 17 had. Did you-all have any other things that you needed to
- 18 bring up with me? Okay. Then I will leave you-all to
- 19 your discussions. If you would please file a proposed
- 20 procedural schedule by the 5th of October.
- 21 We can go ahead and go off the record.
- 22 WHEREUPON, the recorded portion of the
- 23 scheduling conference was concluded.
