**STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission acknowledge MCI WorldCom Communications, Inc.'d, name change to MCI Communications Services, Inc., and MCI WorldCom Network Services, Inc.'s name change to MCI Network Services, Inc.

2. Pursuant to 4 CSR 240-2.060(5), the companies' request for name change clearly sets out the old and new names to be used. In addition, the companies have furnished copies of the Amended Certificates Of Authority Of A Foreign Corporation evidencing registration of the name changes with the Secretary of State. Also, the companies have submitted adoption notices and revised tariff title pages for their respective tariffs.

WHEREFORE, the Staff recommends that the Commission issue an order that acknowledges the new corporate names and that approves the following tariff sheets to become effective September 5, 2005:
