## ORDER DIRECTING RESPONSES TO COMPLIANCE TARIFF

On April 23, 2021, Mid MO Sanitation LLC (Mid MO) filed a notice requesting an increase in its annual overall operating revenues in a staff assisted sewer rate case. On October 28, 2021, the parties filed a disposition agreement resolving all issues. Later on the same day, Mid MO filed a tariff sheet purporting to comply with the pending disposition agreement, and a request for expedited treatment. Essentially, Mid MO requests the tariff sheet be allowed to go into effect on December 4, 2021, although submitted to be effective December 12, 2021, a date which complies with the Commission's 45-day rule.<sup>1</sup>

The Commission will direct the Staff of the Missouri Public Service Commission (Staff) to file an expedited recommendation as to whether the tariff sheets comply with the disposition agreement.

### THE COMMISSION ORDERS THAT:

1. On or before November 8, 2021, Staff shall file a recommendation as directed in the body of this order.
2. Any other party wishing to file a recommendation regarding Mid MO's tariff sheet or a response to Staff's recommendation shall do so on or before November 12, 2021.
