ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On April 23, 2021, Mid MO Sanitation LLC (Mid MO) filed a notice requesting an increase in its annual overall operating revenues in a staff assisted sewer rate case.

In Staff assisted rate cases, Commission Rule 20 CSR 4240-10.075(5)(A) sets forth that Staff and the utility may agree to extensions of various deadlines up to thirty days in length. A total of thirty days of extension have already been agreed to and applied. The rule offers no provisions for further extensions of time.

On October 20, 2021, the Staff of the Missouri Public Service Commission (Staff) filed a request to waive the 150-day requirement for it to file a disposition agreement or a motion to proceed to evidentiary hearing.¹ The parties have already taken advantage of the allowable extension of thirty days provided for in 20 CSR 4240-10.075(5)(A). Staff, indicating that Mid-MO has no objection, requests the Commission waive the 150-day deadline, and extend it until October 29, 2021. The parties believe that the additional time would be helpful in reaching a resolution.

Commission Rule 20 CSR 4240-10.075(15), allows for waiver of any provision of the rule upon a finding of good cause. The Commission finds good cause exists to extend the applicable deadline to allow the parties more time to reach a disposition agreement.

THE COMMISSION ORDERS THAT:

1. Staff's request for waiver of 20 CSR 4240-10.075(11)(A) and an extension of time is granted. The disposition agreement, or a proposed procedural schedule, shall be filed no later than October 29, 2021.
2. This order shall be effective when issued.
