**COMPLAINANT’S MOTION TO APPOINT PROCESS SERVERS**

**COMES NOW** complainant Staff of the Missouri Public Service Commission (“Staff”) and states:

1. Section 386.440.1 RSMo 2000 provides that a subpoena issued by the Commission or any Commissioner may be served by “any person authorized to serve process of courts of record or by any person of full age designated for that purpose by the Commission or by a Commissioner.”

2. The Staff anticipates that to obtain the testimony of Kenneth Matzdorff in this case, it will need to serve Kenneth Matzdorff with one or more subpoenas. The Staff may need to serve subpoenas on others as well.

3. The Staff anticipates serving Mr. Matzdorff with subpoenas when he is in Kansas City, Missouri to appear for federal sentencing. Because it does not know when service may be effected on Mr. Matzdorff and to help ensure someone is available to effect that service, the Staff requests the Commission designate both Cary G. Featherstone and Steve M. Traxler, employees of the Missouri Public Service Commission and persons of full age, as persons authorized to serve subpoenas issued in this case by the Commission or any Commissioner.

4. The Staff suggests the Commission's Order include the language following:  
"Pursuant to Section 386.440.1 RSMo 2000 the Commission designates Cary G. Featherstone and Steve M. Traxler as persons of full age that are authorized to serve subpoenas issued in this case by the Commission or any Commissioner."

**WHEREFORE**, the Staff requests the Commission to issue an Order designating and authorizing both Cary G. Featherstone and Steve M. Traxler to serve subpoenas issued in this case by the Commission or any Commissioner.
