**ORDER APPROVING TARIFF FILED IN COMPLIANCE**  
**WITH COMMISSON ORDER**

Issue Date: October 7, 2005

Effective Date: October 10, 2005

On August 30, 2005, Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, filed its application for competitive classification for business and residential services in certain exchanges. On the same date, the company also filed a proposed tariff (Tariff File No. YI-2006-0144) with an effective date September 29, 2005. On September 26, 2005, the Commission issued its Report and Order granting SBC Missouri competitive status for business and residential services for some, but not all, of the requested exchanges. In addition, the Commission rejected the proposed tariff but authorized the company to file a revised tariff in compliance with the Commission's Report and Order. On September 27, 2005, the Commission issued a Corrected Report and Order.

On September 28, 2005, SBC Missouri filed the instant tariff filing (Tariff File No. YI-2006-0241) with an effective date of October 10, 2005. On October 7, 2005, the Commission's Staff filed its Recommendation and Memorandum. Staff indicates that it has reviewed the revised tariff filing and finds that the business and residential exchanges listed as competitive in the proposed tariff filing match the competitive exchanges in the

Corrected Report and Order. Staff therefore recommends that the Commission either approve the proposed tariff filing, effective October 10, 2005, or allow the tariff to go into effect by operation of law.

The Commission has reviewed the proposed tariff sheets and Staff's Recommendation and Memorandum and is of the opinion that the proposed sheets should be approved effective October 10, 2005.

**IT IS THEREFORE ORDERED:**

1. That the tariff sheets filed by Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, on September 28, 2005, and assigned Tariff File No. YI-2006-0241, are approved to become effective October 10, 2005. The specific tariff sheets approved are as follows:
