**ORDER CANCELING CERTIFICATES AND TARIFF**

Issue Date: April 26, 2006

Effective Date: May 6, 2006

This order cancels the certificates of service authority to provide intrastate interexchange telecommunications services and private pay telephone services granted to MCI Network Services, Inc., along with its accompanying tariff.

On November 17, 2005, the Commission approved the transfer of the assets of MCI Network Services, Inc., to MCI Communications Services, Inc., another subsidiary of MCI, Inc. On April 5, 2006, MCI Network Services filed a pleading indicating that the transaction approved by the Commission has been completed, and that as a result, MCI Network Services is inactive and has no customers in Missouri. MCI Network Services purported to surrender its certificate of authority to provide intrastate interexchange telecommunications services, and asked the Commission to cancel its tariff.

The Commission's Staff filed a recommendation regarding MCI Network Services' request on April 20. Staff confirmed that MCI Network Services has no customers in Missouri, and recommends that the Commission cancel the company's interexchange services certificate and tariff. In addition, Staff recommends that the Commission cancel

MCI Network Services' certificate of service authority to provide private pay telephone services.

Because MCI Network Services had not requested that its payphone certificate be canceled, the Commission directed it to respond to Staff's recommendation. MCI Network Services filed its response on April 25, indicating that it does not object to the cancellation of its pay phone certificate.

The Commission has the authority to cancel a telecommunications corporation's certificates of service authority under Section 392.410.5, which states, "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Since no one has requested a hearing, the Commission may grant the relief requested based on the company's request and Staff's recommendation.

**IT IS ORDERED THAT:**

1. The certificate of service authority to provide interexchange telecommunications services granted to MCI Network Services, Inc., is canceled.
2. MCI Network Services, Inc.'s interexchange tariff, P.S.C. Mo Tariff No. 1, is canceled.
3. The certificate of service authority to provide private pay telephone services granted to MCI Network Services, Inc., is canceled.
4. This order shall become effective on May 6, 2006.

5. This case may be closed on May 7, 2006.
