Dear Sir:

Enclosed for filing on behalf of the Missouri-American Water Company, please find three copies of the revised tariff sheets as listed on Appendix 1 attached hereto.

The purpose of this filing is to implement a general rate increase for water and sewer service provided by Missouri-American Water Company. The revised water rates were designed to produce an additional \$20 million in gross annual water revenues (excluding gross receipts and sales taxes) or a 12.2% increase over existing water revenues. The revised sewer rates were designed to produce an additional \$1,637.00 in gross annual sewer revenues (excluding gross receipts and sales taxes) or a 3.3% increase over existing sewer revenues.

Please note that the attached tariff sheets bear an issue date of May 19, 2003, and are proposed to become effective June 18, 2003.
