ORDER DENYING APPLICATION FOR REHEARING

On March 16, 2022, the Commission issued a revised order granting variances and granting waiver regarding DCM Land, LLC and Missouri-American Water Company's request for a variance from Missouri-American's tariff provisions regarding the extension of its water mains. That order became effective on March 26, 2022. The Office of the Public Counsel (Public Counsel) filed a timely application for rehearing on March 25, 2022.

Section 386.500.1, RSMo (2016), indicates the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, Public Counsel has not shown sufficient reason to rehear the revised order. The Commission will deny the application for rehearing.

THE COMMISSION ORDERS THAT:

1. Public Counsel's *Second Application for Rehearing* is denied.
2. This order shall be effective when issued.
