Missouri-American Water Company (MAWC) filed an *Application and Motion for Waiver* requesting authority from the Commission to issue long-term debt to the Missouri Department of Natural Resources in an amount not to exceed \$11,500,000. MAWC also seeks authority from the Commission to secure the long-term indebtedness by placing a mortgage upon its property. The Commission will issue an order requesting the Staff of the Commission to file a pleading informing the Commission of the date certain it anticipates filing a recommendation on MAWC's Application.

THE COMMISSION ORDERS THAT:

1. No later than September 10, 2021, the Staff of the Commission shall file a pleading specifying the date certain it will file its recommendation regarding MAWC's Application.
2. This order is effective when issued.
