

5. On or about May 16, 2005, after good faith negotiations, MoKan and T-Mobile executed a Traffic Termination Agreement ("Agreement") for the state of Missouri pursuant to the terms of the Act (*see* Agreement, Attachment I).

6. Pursuant to the Act, MoKan hereby submits this Agreement for approval by the Commission.

7. The Agreement complies fully with Section 252(e) of the Act because the Agreement is consistent with the public interest, convenience, and necessity and does not discriminate against any telecommunications carrier. The Agreement consists of 20 pages.

8. There are no outstanding issues between MoKan and T-Mobile that need the assistance of mediation or arbitration.

REQUEST FOR APPROVAL

9. MoKan requests the Commission's approval of the Agreement, consistent with the provisions of the Act and Missouri Law. This is a bilateral agreement, reached as a result of negotiations and compromise between the parties. MoKan represents that the implementation of this negotiated and executed agreement complies fully with both Missouri Law and section 252(e) of the act, because the agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier.

10. MoKan respectfully requests that the Commission grant expeditious approval of this agreement, without change, suspension or delay in its implementation.
