RECOMMENDATION REGARDING CONSOLIDATION OF CASES

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its <u>Recommendation Regarding Consolidation of Cases</u> (Recommendation), states the following:

- 1. On November 20, 2009, Staff filed with the Missouri Public Service Commission (the Commission) four complaints (the Complaints), naming as respondents Aqua Development Company d/b/a Aqua Missouri, Inc. (Case No. SC-2010-0150), Aqua Missouri, Inc. (Case Nos. WC-2010-0151 and SC-2010-0152) and Aqua RU, Inc. d/b/a Aqua Missouri, Inc. (Case No. WC-2010-0153).
- 2. In addition to the <u>Complaints</u>, these entities are currently pursuing revenue increase requests (the rate cases) through the Small Utility Rate Case Procedure found at Commission Rule 4 CSR 240-3.050.
- 3. On November 24, 2009, the Commission issued its <u>Order Directing Staff to File a</u> <u>Recommendation</u>, ordering Staff to file by December 28, 2009, a recommendation as to the consolidation of any or all of these matters.

4. Commission Rule 4 CSR 240-2.110(3) states that "[w]hen pending actions involve related questions of law or fact, the Commission may order a joint hearing of any or all of the matters at issue, and may make other orders concerning cases before it to avoid unnecessary costs or delay."

5. Because the pending <u>Complaints</u> involve related questions of law and fact and their consolidation may avoid unnecessary cost or delay, Staff supports consolidation of the <u>Complaints</u> into one matter.

6. At this time Staff is unable to provide a recommendation regarding consolidation of the rate cases. Staff will submit its recommendation regarding consolidation of the rate cases by December 28, 2009, as previously ordered by the Commission

WHEREFORE, Staff submits this <u>Recommendation</u> and asks that the Commission enter an Order consolidating Case Nos. SC-2010-0150, WC-2010-0151, SC-2010-0152 and WC-2010-0153.
