Enclosed for filing with the Commission are an original and three copies of revised tariff sheets that include rate and language changes reflected in an Agreement Regarding Disposition of Small Company Rate Increase Request (Disposition Agreement) between the West 16th Street Sewer Company and WPC Sewer Company (Company), the Commission Staff (Staff) and the Office of the Public Counsel (OPC) regarding the above-referenced small company rate increase request. The Company submitted the referenced rate increase request on September 11, 2006 under the provisions of the Commission's small company rate increase procedure, and the request was assigned the above-referenced tracking number.

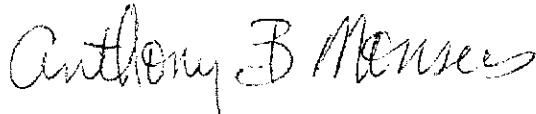
