**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND
SETTING A TIME FOR RESPONSES**

On September 1, 2021, the Commission directed its Staff (Staff) to file a pleading stating the date that Staff would be able to file a recommendation on Missouri-American Water Company's (MAWC's) *Application and Motion for Waiver*, requesting authority to issue long-term debt. Staff filed a pleading on September 10, 2021, stating that it can file a recommendation by October 28, 2021. The Commission will direct Staff to file a recommendation by that date.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding MAWC's application no later than October 28, 2021.
2. Any responses to Staff's recommendation or other responses to MAWC's application shall be filed no later than November 5, 2021.
3. This order is effective when issued.
