RULES GOVERNING RENDERING OF WATER SERVICE

RULE 7 DISCONTINUANCE OF WATER SERVICE BY COMPANY

- (a) The Company may discontinue water service for any of the following reasons:
 - 1. Nonpayment of a delinquent account not in dispute.
 - 2. Failure to post a security deposit or guarantee acceptable to the utility.
 - Unauthorized interference, diversion or use of the utility service situated or delivered on or about the customer's premises.
 - 4. Failure to comply with the terms and conditions of a settlement agreement.
 - Refusal to grant access at reasonable times to equipment installed upon the premises of the customer for the purpose of inspection, meter reading, maintenance, or replacement.
 - 6. Violation of any of these rules and regulations on file with and approved by the Commission, or for any conditions which adversely affects the safety of the customer or other persons, or the integrity of the utility's delivery system.
 - 7. Non payment of a sewer bill issued by the Company, or * by sewer utility requesting discontinuance of water service by an aproved agreement between the Company and such sewer utility. When water service is discontinued for this reason, any service charges for turn on/off or disconnection/reconnection within these rules shall not apply, and notice of the customer shall be provided by rules applicable to the customer's sewer service in lieu of notification required by these rules.
- (b) The Company may discontinue service after notice by first class mail is sent to the customer at least ten (10) days + prior to the date of the proposed discontinuance. If written notice is hand deliverd to the customer, it shall be done at least ninety-six(96) hours prior to discontinuance.+ Service of notice by mail is complete upon mailing.
