Discussion Points

Maintaining the Option for a New Nuclear unit in Missouri

- Two years ago AmerenUE filed a COLA with the NRC Why?
 - Anticipated future needs of AmerenUE's customers & other potential partners for clean, reliable baseload resource
 - Diversify AmerenUE's generation portfolio from environmental perspective
 - Take advantage of federal loan guarantees and tax credits could have reduced cost of project by billions of dollars
- Contingent on passage of legislation to enable low-cost financing approach similar to other states legislation did not pass.
 - COLA was placed on hold with NRC
- Missouri's electric service providers have been exploring options to meet future electricity needs in light of:
 - Aging fleet of baseload power sources
 - Impact of current and proposed EPA regulations
 - Desire to diversify our portfolio of generation resources
 - Need to access to clean, low-cost, reliable baseload options in the future
- Missouri's electric service providers agree that pursuit of an Early Site Permit (ESP) from the NRC is in the best interest of all Missourians.
 - Significant environmental regulation unknowns will drive important generation resource decisions in a few years an ESP will position us to take advantage of nuclear option if it is the best option for all Missourians.
- What is an ESP?

- Enables companies to obtain approval from the NRC for a site before deciding to build a plant or choose a particular technology.
 - Site Safety Analysis
 - Environmental Report
 - Emergency Planning Information
- Resolves site suitability questions prior to commitment of major funds to build a project.
- An ESP is an asset and can be banked for up to 20 years with possible renewal for another 20 years.
- Can encompass a wide range of reactor technology options.
- Key Advantages of an ESP?
 - Resolves site suitability questions for Callaway site
 - Better positions Missouri for federal tax incentives and loan guarantees in the future
 - Allows for 'lessons learned' from projects moving ahead in other regions
 - Allows for reassessment of a range of nuclear power technologies as they further develop
 - Permits additional time to develop energy efficiency programs and renewable energy resources
 - Additional time to see what environmental rules and financing approaches develop
 - o Allows for competitive bidding of nuclear technologies in the future
 - Allows more time for dialog and collaboration
 - ESP first, COLA second \rightarrow preferred NRC approach
- Customer protections include...
 - o Short simple legislation that only allows for recovery of a site permit
 - o Can only recover cost of the site permit if the NRC grants the permit
 - Dollars spent to obtain the site permit will be subject to MoPSC prudence review
- What the ESP initiative is...
 - An initiative of all the electric service providers in Missouri
 - A measured approach to preserve the option to build a nuclear power plant if it is determined to the best option for Missourians
- What the ESP initiative is <u>not</u>...
 - A broad-based repeal of the anti-CWIP statute
 - A "reboot" of the legislation two years ago
- Other Possible 2011 Session Legislation briefly discussed:
 - FERC authority legislation
 - Water/DNR Fees legislation
 - OPC Funding
 - Underground Damage Legislation

- Commissioner Davis expressed concerns about the cost overruns at SPP.
 - He also expressed concerns regarding estimates for the MVP projects at MISO.
 - Stated at some point in time discussion should be held whether it is still prudent for Ameren Missouri to be a MISO member.
- Renewable Energy Standard workshops were briefly discussed.
 - An additional workshop was scheduled for December 13, with the December 7 workshop being a smaller group setting.
