The instant tariff filing, Tariff File No. YI-2006-0241, filed on September 28, 2005, lists the Southwestern Bell Telephone, LP d/b/a SBC Missouri (SBC) exchanges that are classified as competitive for either residential services (Sheet 3) or business services (Sheet 1). This tariff was filed in accordance with the Corrected Report and Order released 9-27-06, effective 9-29-05, in Case No. TO-2006-0093, *In the Matter of the Request of Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, for Competitive Classification Pursuant to Section 392.245.6, RSMo (2005) - 30-day Petition*.

## **History**

On August 30, 2005, SBC filed a tariff filing (designated Tariff File No. YI-06-0144) with an effective date of 9-29-05 and a request for competitive classification. Multiple parties filed testimony and a hearing was held in the 30-day SBC case on 9-16-05.

On September 26, 2005, the Commission issued its Report and Order in the 30-day SBC case granting competitive status to 26 residential exchanges and competitive status to 45 business exchanges. Within this Report and Order, the Commission rejected SBC's original 30-day tariff filing, Tariff File No. YI-2006-0144, as not being in compliance with the Commission's decision in the 30-day SBC case.

On September 27, a correction was filed to the Report and Order, and a full Corrected Report and Order was issued.

On September 28, 2005, SBC filed the instant tariff filing, Tariff File No. YI-2006-0241, with an effective date of 10-10-05, to comply with the Commission's Corrected Report and Order in the 30-day SBC Case.

## **Recommendation**

Staff has reviewed the filing and recommends approval as the residential and business exchanges listed as competitive in the instant tariff filing match the competitive exchanges in the Corrected Report and Order.
