ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING
REQUEST TO INTERVENE, AND ESTABLISHING TIME FOR FILING
RECOMMENDATION

This order directs that notice be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On February 23, Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, filed an application under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission overturn a decision of the North American Numbering Plan Administrator. This application concerns SBC's service to the Department of the Treasury, Internal Revenue Service, a customer of AT&T Missouri in the Kansas City area that is consolidating eight existing locations in the Kansas City metropolitan area into one new complex. AT&T requests that the Commission act on this application within ten days.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. The Commission will direct its Data Center to send a

copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. Additionally, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and establish a date by which any other party wishing to respond must do so.

IT IS ORDERED THAT:

1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.

2. Any company wishing to intervene or request a hearing shall do so by filing an appropriate pleading no later than March 3, 2006, with:

3. The Staff of the Commission shall file a recommendation regarding Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri's Application no later than March 6, 2006.

4. Any other party wishing to file a recommendation regarding Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri's Application shall do so no later than March 6, 2006.

5. This order shall become effective on February 27, 2006.
