ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING
REQUESTS TO INTERVENE, AND ESTABLISHING TIME
FOR FILING RECOMMENDATIONS

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On September 11, 2006, Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, filed an application under 47 C.F.R. 52.15(g)(3)(iv) requesting that the Commission review and reverse a decision of the North American Numbering Plan Administrator, NeuStar, Inc., to withhold certain numbering resources from AT&T Missouri in the form of four thousand-number blocks of numbers to meet the needs of its customer, J.P. Morgan Chase Bank, in the 816 NPA. AT&T Missouri's application included a motion for expedited treatment.

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for

interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

IT IS ORDERED THAT:

1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.

2. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than September 19, 2006, with:

3. The Staff of the Commission shall file a recommendation regarding Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri's application no later than September 20, 2006.

4. Any other party that wishes to file a recommendation regarding Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri's application shall do so no later than September 20, 2006.

5. This order shall become effective on September 12, 2006.
